Summary of Site Work Completed in 2023 and Planned for 2024:

Work Completed in 2023: Performed operation and maintenance, including system repairs to the onsite groundwater treatment system (GWTS) to protect the adjacent creek. Performed compliance monitoring and reporting (i.e., biannual corrective action groundwater sampling and submittal of two reports; and discharge monitoring and quarterly reporting). Prepared the Additional Site Investigation (ASI) Work Plan and submitted (in October) to LDEQ for review and approval. Began field planning efforts, including but not limited to procurement and document (e.g., field instructions) activities, to implement the ASI activities recommended in the 2023 Calhoun Gas Plant Site Source ASI Report and 2023 ASI Work Plan necessary to investigate the Calhoun Gas Plant property (i.e., Non Owned Other Site - Calhoun Facility, also known as the Regency Gas Plant property) as a potential upgradient source. Note that costs associated with the Non Owned Other Site - Calhoun Facility are not billed to the Owned Funded Site - Calhoun Remediation Site's Environmental Cost Account (ECA) and instead are billed to the Non Owned Other Site's cost account. Prepared Multistate Trust 2022 Annual Progress Report.

Work Planned for 2024: Perform operation and maintenance, including system repairs to the onsite groundwater treatment system to protect the adjacent creek. Perform site maintenance, operations, compliance monitoring and reporting (biannual corrective action groundwater sampling/reporting and monthly surface water discharge monitoring/reporting). Complete one Sitewide groundwater sampling event to inform the Non Owned Other Site source investigation in accordance with 2023 ASI Work Plan, and based on the combined results, update the overall sitewide remediation strategy, inclusive of both the Calhoun Remediation Site and the Non Owned Other Site - Calhoun Facility. This sampling event is anticipated to close out remaining data gaps for the Calhoun Remediation Site and to finalize understanding of nature and extent of contamination as basis for the Risk Evaluation / Corrective Action Program (RECAP) evaluation. Based on the overall schedule to complete the 2024 proposed activities, a budget amendment may be submitted to prepare the corrective action plan (CAP) and begin designing the final remedy. Note that while combined reports will be prepared, the costs associated with the Owned Funded Site - Calhoun Remediation Site are not billed to the Non-Owned Other Site - Calhoun Facility's cost account and instead are billed to the Owned Funded Site's ECA. Prepare the Multistate Trust 2023 Annual Progress Report (portion specific to the Site).
