Work Completed in 2023: Performed routine maintenance. Completed the Final OU1 Remedial Design package for cap, bulkhead, dredging, ISS, P&T (100%) which is pending final approval. Utilized Fate & Transport Model to support the revised final remedial design scenarios and long term monitoring. Modified permit applications or continued permitting process (USACE, FDEP ERP, JEA IUDP) based on the final design and completed JEA IUDP and USACE permitting process with FDEP ERP permit pending final comment. Largely completed procurement for the OU1 remedy Construction by issuance of three bid packages, bid walks, proposal evaluations, contractor interviews and negotiations. Continued work on development of institutional controls for OU1 remedy. Participated in monthly technical working group discussions and various stakeholder meetings. Held public meetings and engagement for review of 100% design and pending construction. Coordinate end user property improvements with remedy. Obtained site access for Remedial Investigation for Deer Creek/OU2 and prepared for upcoming field activities.

Work Planned for 2024: Perform routine maintenance prior to construction. Complete remedial design adjustment for treatment system, and foundation layer adjustments. Complete permitting (USACE, FDEP ERP, JEA IUDP) by obtaining final JEA Permit, finalizing comment response for FDEP Letter of consent and USACE 408 consultation. Finalize contract for and install OU1 remedy including: low permeability cap, ISS, construction of environmental bulkhead, sediment dredging, P&T system. The Multistate Trust will monitor actual costs incurred and impacts to the 2024 ECA budget and if necessary, submit a budget amendment. Current construction budget is based on the engineer's estimate, a budget amendment may be requested for construction components after a construction proposal is received. Obtain institutional controls for OU1 remedy. Continue technical working group and various stakeholder meetings. Hold public meetings for construction and OU2 Investigation as necessary. Coordinate end user property improvements with remedy.
