Summary of Site Work Completed in 2023 and Planned for 2024:

Work Completed in 2023: Performed operations and maintenance (O&M) of the groundwater and product treatment system (Treatment System). Performed compliance sampling, monitoring, and reporting associated with the Wastewater Discharge Permit and Missouri Hazardous Waste Management Facility (MHWMF) Part I Permit (Permit or MHWMF Part I Permit), including quarterly (where applicable) and semiannual groundwater monitoring and submittal of the 2022 Annual Groundwater and Corrective Action Report (AGCAR) to the Missouri Department of Natural Resources (MoDNR). Began preparing the 2023 AGCAR for submittal to MoDNR by March 1, 2024. Finalized the Wastewater Exemption Rule Technical Memorandum and submitted to MoDNR. To support Treatment System optimization and Blue River sheen management and risk analysis, the Multistate Trust's third-party contractor submitted a technical memorandum summarizing repair/replacement options for recovery well, RW-08, and the preliminary daft Blue River Monitoring Work Plan to the Multistate Trust in late-Q4 for review and input. In support of the risk evaluation framework, submitted the draft human health and ecological conceptual site exposure models, along with data quality objectives (DQO) tables to MoDNR to support future discussions regarding remaining data needs to position the site for final remedy and reuse (it is anticipated that the final risk evaluation framework will be submitted in early 2024):ovided on-call subject matter expertise and other technical support services as needed. Performed on-going maintenance of the environmental relational database. Received approval from MoDNR to utilize local non-profit organization that specializes in reuse planning and economic redevelopment initiatives to undertake a land use planning initiative in order to (i) leverage the City of Kansas City's strategic goals for Blue River Valley (BRV) revitalization, (ii) develop conceptual plans for integrating long-term site stewardship and groundwater corrective actions into future reuse of the site, and (iii) identify options for improving property access. Prepared Chapter 3.M (specific to the Site) of the Multistate Trust 2022 Annual Progress Report.

Work Planned for 2024: Perform Treatment System O&M, including operating the Treatment System, routine repairs, cleanout of the biological aeration tank [BAT] (pushed from 2023 to 2024), and waste disposal. waste, and planned repairs. Perform mowing and site security. Perform compliance sampling, monitoring, and reporting associated with the Wastewater Discharge Permit and MHWMF Part I Permit, including quarterly (where applicable) and semiannual groundwater monitoring. Complete and submit the 2023 AGCAR to MoDNR by March 1, 2024. Finalize the Blue River Monitoring Work Plan for submittal to and approval by MoDNR, collect samples from the Blue River upon MoDNR approval of the work plan, and prepare a brief technical memorandum summarizing the Blue River sampling data. Finalize the risk assessment framework, including human health and ecologica conceptual site exposure models and data quality objections to close remaining data needs to position the site for final remedy and reuse and prepare a supplemental RAO/risk assessment data gaps work plan (subject to MoDNR concurrence on the risk assessment framework) for additional data collection (e.g., critical habitat). Conduct a groundwater plume (i.e., dissolved phase) and dense-nonagueous phase liquid (DNAPL) stability evaluation analysis and prepare a technical memorandum to summarize the findings / recommendations / conclusions to support the CMS or equivalent and develop alternative concentration limits (ACLs). Maintain the site's environmental relational database. Utilize local non-profit organization that specializes in reuse planning and economic redevelopment initiatives to undertake a land use planning initiative as described above. The budget also includes on-call subject matter expertise and other technical support services as needed. Participate in ongoing Beneficiary and stakeholder communications including with the City of Kansas City, Jackson County, U.S. Army Corp of Engineers, and the public as necessary.
