Summary of Site Work Completed in 2022 and Planned for 2023:

Work Completed in 2022: Conducted a Phase 2 Environmental Site Assessment consisting of a property survey, utility clearance, soil sample collection from three soil piles on-site and advancement of seven soil borings using DPT method, collecting two soil samples from each boring. Each boring was also converted to a temporary well to collect filtered and unfiltered groundwater samples. All samples were submitted to a licensed testing laboratory to test for VOCs, SVOCs, and RCRA metals. A Phase 2 ESA Report was prepared to document this work (scheduled to be submitted to EPA and WDNR for review and comment in December 2022).

Work Planned for 2023: Respond to EPA and WDNR comments on the Phase 2 Environmental Site Assessment Report (scheduled for submittal in December 2022), finalize and obtain EPA and WDNR approval of the Phase 2 ESA Report. Abandon seven temporary wells. Meet with EPA and WDNR to discuss long-term management plan for site. Explore post-investigation long-term stewardship options, including through establishment of institutional controls and/or installation of security (e.g., fencing). No sampling, site investigation, or remediation is planned in 2023; if desired, a budget amendment will be requested.
