Summary of Site Work Completed in 2021 and Planned for 2022:

Work Completed in 2021: Finalized and submitted the Supplemental Remedial Investigation (SRI) Approach Scenario Memorandum and cost estimates for each of the 3 proposed scenarios for conducting a SRI to the Illinois EPA. Participated in a technical meeting with the Illinois EPA to determine whih scenario to implement from the SRI Approach Scenario Memorandum. Submitted a 2021 ECA budget amendment to complete the SRI Work Plan. Began the preparation of the SRI Work Plan, including the Health and Safety Plan (HASP), Waste Management Plan (WMP) and Quality Assurance Project Plan (QAPP) (collectively the SRI Work Plan). Began developing a strategy to remove the Site from the "Critical Sites List" and for participated in discussions with the Illinois EPA and the United States.

Work Planned for 2022: Continue the preparation of the preparation of the SRI Work Plan for Illinois EPA review and approval; conduct a property survey and prepare a Site topographic map; and confirm offsite property ownership and support the preparation of access agreements for locations where offsite investigations are proposed. As previously discussed with Illinois EPA, the SRI Work Plan prioritizes the dense nonaqueous phase liquid (DNAPL) source delineation, extent of on- and offsite groundwater impacts and investigations to evaluate the potential for vapor intrusion at nearby residential properties. Budget ncludes costs for ongoing discussions with the Illinois EPA and United States regarding the strategy to remove the Site from the "Critical Sites List"

Note: A 2022 ECA budget amendment will be submitted to Illinois EPA for the implementation of the SRI field investigation and preparation of the SRI report after the approval of the SRI Work Plan. Prior to submitting the budget amendment, a revised cost estimate will be prepared to implement the SRI Work Plan as writen. The Multistate Trust and the Illinois EPA will participate in a virtual meeting to discuss comments on the SRI Work Plan and the associated cost estimate.

The budget increase of \$20,000 is a placeholder allowance to account for transition costs.

The 2021 ECA Budget Amendment was approved by Illinois EPA on November 9, 2021. A notice to proceed was issued to the Multistate Trust third-party contractor on November 16, 2021; thus, costs to prepare the SRI Work Plan are anticipated to be minimal in 2021. Therefore the entire 2021 ECA Budget Amendment amount for the preparation of the SRI Work Plan and the Initial Field Work Pre-Planning tasks were included in the 2022 ECA Budget (\$134,000). Additionally, \$25,000 is included in the budget for Multistate Trust third-party contractor project management. After Illinois EPA has had the opportunity to review the SRI Work Plan, a 2022 ECA Budget amendment will be submitted to incorporate costs to implement the SRI Work Plan field investigation activities and to prepare the SRI report.

This Single Page Document Constitutes the Annual Budget Submitted to the Lead Agency under Section 3.2.4 of the Multistate Environmental Response Trust Agreement. Supplemental Worksheets, if any, Do Not Comprise a Portion of the Annual Budget.

Subject to further consultation with its Lead Agencies and the United States, the Multistate Trust currently defines an Owned Funded Site (OFS) as a "Critical Site" if the OFS lacks sufficient Environmental Cost Account (ECA) funds to address one or more of the following criteria or conditions: (i) Known, uncontrolled, unacceptable or potentially unacceptable exposure of human and/or ecological receptors to OFS site contaminants; (ii) Uncontrolled migration of OFS contaminants off-site at concentrations that exceed applicable risk-based criteria; (iii) Unable to characterize the nature and extent of contamination to determine whether there is an unacceptable exposure of human health and the environment to OFS contamination, and to implement protective remedies; and (iv) Potential impacts to drinking water supplies, actual or likely direct human contact and sensitive socioeconomic impacts, including Environmental Justice communities and populations at risk, because the Multistate Trust endeavors to prioritize such OFSs.

Critical Sites need an infusion of funds sufficient to address the above criteria so that an OFSs is no longer classified as a Critical Site. Additional funds will likely be necessary to achieve regulatory closure. While many OFSs may lack sufficient funds to achie regulatory closure (including long-term stewardship), funding shortfalls in those cases can potentially be addressed by funding receipts from waterfalling funds under the Settlement Agreement and Multistate Trust Agreement, interest income, the sale of and/or the transfer of such responsibility to a successor to the Multistate Trust.
