Work Completed in 2021: Continued post-closure care of closed hazardous waste impoundment and ongoing groundwater monitoring in spring 2021; submitted Class II Permit Modification request to MDEQ to suspend the groundwater monitoring and sampling requirements*; performed site security and routine maintenance activities; completed and submitted HHRA and BERA reports for EPA and MDEQ review and approval; began preparing draft CMS report for the Facility based on comments received from EPA and MDEQ on the Non-Process Area draft CMS report submitted to EPA and MDEQ in 2020; Project management and regular communication with EPA and MDEQ.

*Note: Only spring groundwater sampling and monitoring activities were completed at the Facility.

Work Planned for 2022: Continue post-closure care of closed hazardous waste impoundment**; perform site security and routine maintenance; complete 2021 groundwater monitoring compliance report; complete preparation of draft and final Corrective Measures Study report for EPA and MDEQ review and approval; Project management and regular communication with EPA and MDEQ; and community outreach and redevelopment initiatives.
