Summary of Site Work Completed in 2021 and Planned for 2022:

Work Planned for 2022: Continue WP-6 compliance monitoring and maintenance, Site mowing and maintenance, including perimeter fence and Site building and equipment; evaluate additional Site maintenance needs and provide recommendations. Perform initial repairs to Site building to address damage caused by vandals, evaluate site security and future needs for building to determine scope of building repairs and need for additional maintenance. Solicit contractor proposals for approved non-routine maintenance activities and building repairs and review approved 2022 ECA budget to determine if funds are sufficient. Prepare sheen response sampling report and develop sheen response plan. Address DEQ review comments on draft groundwater characterization report. Based on DEQ approval of draft groundwater characterization report, prepare groundwater investigation work plan for DEQ review and approval. Implement groundwater investigation work per DEQ-approved work plan, update Conceptual Site Model based on new information and prepare draft report (one comprehensive sampling event is assumed in this scope and budget forecast). Perform surface soil sampling at "City Lot" and prepare report and recommendations; continue communications with City of Cleveland and outline potential reuse options and considerations, as appropriate.

Work Associated with Amended Budget (Amendment No. 1): Pursuant to discussions with DEQ, the off-Site disposal cost-benefit analysis for WP-6 will be deferred until after the completion of the Groundwater FS; thus, this budget amendment removes the costs associated with this analysis from the 2022 ECA budget. This budget amendment also includes costs to (i) revise the Groundwater Feasibility Study Work Plan based on DEQ comments and (ii) enter into a contract with the Multistate Trust's third-party contractor(s) in December 2022 to (a) implement the Groundwater FS investigation activities, including Site clearing, utility locating, topographic surveying/mapping, geophysical surveying, underground pipeline test pits and fluids sampling, source area investigations with both soil and soil gas sampling, surface water, sediment, and groundwater sampling, field sheen/response testing, light nonaqueous phase liquid (LNAPL) investigation activities, including absence/presence and thickness measurements and step-out borrings/monitoring, installation of two new monitoring wells, abandonment of one damaged monitoring well, and investigation derived waste (IDW) management and disposal; (b) develop the remedial action objectives (RAOS); (c) prepare the FS Report; (d) support the Proposed Plan and Decision Document; and (e) support public meeting outreach, including fact sheets, meeting materials and meeting participation. Pursuant to §3.2.4 of the Trust Agreement, no expenses can be incurred or paid by the Multistate Trust that are "inconsistent with an approved budget or an approved revised line item for an approved budget," except for ongoing or recurring expenses approved in the previous year's budget. Therefore, the Multistate Trust is submitting this 2022 ECA Budget Amendment to include Environmental Actions related to groundwater feasibility study, which will allow the Multistate Trust to continue work into 2023, pending ODEQ's approval of the 2023 ECA Budget for the Site.
