Summary of Site Work Completed in 2022 and Planned for 2023:

Work Completed in 2022: Updated and achieved Texas Commission on Environmental Quality (TCEQ) approval of the Final Land Based Operable Unit (LBOU) Remedial Action Effectiveness Report (RAER). Prepared, submitted and achieved TCEQ approval of the Brakes Bayou Operable Unit (BBOU) Data Gaps Investigation (DGI) Work Plan, and began BBOU DGI field investigation activities (will extend into 2023). Obtained TCEQ approval of the LBOU Groundwater DGI Technical Memorandum, and subsequently abandoned six deep monitoring wells, located on- and off-Site. Performed routine Site operations, maintenance and regulatory compliance activities, including Site caretaking, bi-weekly BBOU sheen inspections, monthly Site inspections and reporting, annual long-term monitoring (LTM) sampling and reporting, and permit compliance reporting to the City of Beaumont. Conducted emergency Site visits/inspections before and after hurricanes as needed. Supported preparation of Chapter 3.X (specific to the Site) of the Multistate Trust 2021 Annual Progress Report.

Work Planned for 2023: Complete BBOU DGI field investigation and prepare BBOU Geotechnical Memorandum. Provide decision document support to TCEQ regarding preparation and finalization of the Proposed Remedial Action Documents (PRADs) and Administrative Orders for both the LBOU and BBOU, including preparations, attendance, and public outreach for associated public meeting(s). Perform routine Site operations, maintenance and egulatory compliance activities, including Site caretaking, bi-weekly BBOU sheen inspections, monthly Site inspections and reporting, and annual LTM sampling and reporting. Conduct emergency Site visits/inspections before and after hurricanes as needed. The ECA budget does not include costs to begin the LBOU or BBOU remedial design in 2023. Based on discussions with TCEQ, the Administrative Orders for both the LBOU and BBOU won't be igned until early 2024; thus, the LBOU and BBOU remedial design are not anticipated to start until 2024. If remedial design tasks are desired in 2023, a budget amendment will be requested. The budget assumes that the groundwater and creosote recovery and treatment plant (GWTP) will remain off-line in 2023. If the GWTP requires operation or decommissioning, a budget amendment will be requested. Support preparation of the Multistate rust 2022 Annual Progress Report (portion specific to the Site).

The 2023 ECA budget assumes that the GWTP will remain off-line in 2023. The budget also includes (i) permit-required reporting to the City of Beaumont (City), and communications with the City (e.g., inspections, industrial wastewater survey, etc.); (ii) routine Site maintenance, including mowing and maintaining security, annual groundwater monitoring and reporting to TCEQ, and monthly status reporting to TCEQ; (iii) utilities and meter calibrations; (iv) a \$4x allowance for investigation derived waste (IDW) disposal costs for future IDW generation; (v) annual lease fee to the Texas General Land Office (GLO) for bayou, alarm and permit fees; and (vi) a \$20k allowance for unplanned events, maintenance, or emergency response. If the GWTP requires operation or decommissioning, a budget amendment will be requested. Utilities, laboratory charges and other routine O&M budgets have been estimated to account for potential rate adjustments due to inflation. The Multistate Trust will monitor actual costs incurred and impacts to the 2023 ECA budget and if necessary, submit a budget amendment.

The budget also includes costs for Dr. Rob Hinchee to provide subject matter expertise, including review and comment on work planning, data evaluation, report conclusions/recommendations, remedial selection, and other remediation issues for the Site. The 2023 ECA budget is lower than the 2022 ECA budget because no design costs are included in the 2023 budget, while some design costs were included (to be used only if authorized by TCEQ) in the 2022 ECA budget.
