Summary of Site Work Completed in 2022 and Planned for 2023:

Work Completed in 2022: Achieved Texas Commission on Environmental Quality (TCEQ) conditional approval of the Response Action Plan. Prepared RCRA Hazardous Waste Permit Renewal/Modification application for Permit No. 50076 (to be submitted in December). Performed soil to outdoor air sampling/reporting, and obtained TCEQ approval to proceed with soil cap design without vapor barriers. Completed pre-excavation soil delineation ampling as inputs to soil capping and soil excavation designs. Completed 60% remedial designs for Days Creek re-route, Waggoner Creek lining, and soil capping (all expected by December 2022). Performed soil excavation procurement, with field implementation scheduled to commence in December 2022. Initiated cultural resources survey and U.S. Army Corps of Engineers (USACE) permit applications for Days and Waggoner Creek remedial construction (expected complete in early 2023). Prepared Draft on-Site deed restrictions and off-Site restrictive covenants, and coordinated review with TCEQ and off-Site land owners. Prepared a Communication and coordination Plan for, and held meetings with TCEQ and the City of Texarkana to coordinate Multistate Trust and City construction projects located in close proximity to each other. Performed routine Site O&M and 5-year tank nspections. Completed well abandonment of approximately 70 monitoring wells. Performed all compliance activities, monitoring, and reporting, to meet the requirements of the TWU wastewater discharge permit, post-closur care requirements for the on-Site hazardous waste management unit, and other long-term monitoring requirements for the Site. Supported preparation of Chapter 3.2 (specific to the Site) of the Multistate Trust 2021 Annual Progress Report.

Work Planned for 2023: Complete the renewal/modification of RCRA Hazardous Waste Permit No. 50076. Complete/submit permit application to USACE for Days and Waggoner Creek remedial construction, including completing a 'No Rise' flood plain surface water model if required by Bowie County (Costs for Days Creek re-route construction are not included in 2023 budget; anticipated in 2024/2025). Complete soil excavation remedial iction (scheduled to begin in December 2022), including soil excavation Remedial Action Completion Report (RACR). Achieve TCEQ approval of soil capping design and Waggoner Creek liner design; refine soil capping and creek iner construction costs by initiating competitive procurement (Costs for soil capping and Waggoner Creek liner construction are not included in 2023 budget; if construction desired in 2023 a budget amendment will be submitted). Implement on-Site deed restrictions and off-Site restrictive covenants. Perform routine Site O&M. Perform all compliance activities, monitoring, and reporting, to meet the requirements of the TWU wastewater discharge permit, post-closure care requirements for the on-Site hazardous waste management unit, and other long-term monitoring requirements for the Site. Support preparation of the Multistate Trust 2022 Annual Progress Report (portion specific to the Site).

The Multistate Trust will monitor actual costs incurred and impacts to the 2023 ECA budget and if necessary, submit a budget amendment.
