Summary of Site Work Performed in 2022 and Planned for 2023: <u>OSS No. 55, located at 405 South Main Street, Tuscola, IL.</u> Work Conducted in 2022: Conducted regulatory and historical file review to establish site background. Completed and submitted the IEPA Site Remediation Program (SRP) Application and Services Agreement Form (DRM-1). As required by the DRM-1 Form provided: Remediation Site Identification, Remediation Site Base Map, Remediation Applicant (RA) Identification, Project Objectives, Indication that the RA is the property owner, and made a partial advance payment of \$500 when submitting the SRP Application and DRM-1. Work Planned for 2023: Develop a Work Plan detailing the site assessment activities, consisting of a certified property boundary survey, utility locate including a ground penetrating radar survey and installation of eighteen soil borings. Six of the soil borings will be converted into permanent monitoring wells. Groundwater samples will be collected from the five monitoring wells. A Focused Site Investigation Report will be developed summarizing the investigation activities and analytical results for submittal to IEPA. Includes \$15,000 IEPA oversight fees associated with site management, review of the Work Plan and Focused Site Investigation Report.
